__27. (One/Another) reason why the sale of the BWL is opposed is because as a City owned utility, not investor owned like Consumers Energy or DTE Energy, BWL electric rates are lower. This is especially true if Consumers Energy gets approval from the Michigan Public Service Commission for their latest rate increase request, which would make electric rates for BWL residential customers nearly 10 percent less than Consumers Energy rates. Also, if the BWL is purchased by another utility just for electric service and water service is then transferred to another city department, both electric rates and water rates would significantly increase for Lansing residents.
